

Whereas, the City and State, through the Riverfront Development Corporation and the Christina Gateway Corporation, will be developing a new riverfront park at the southern gateway to the city adjacent to the Amtrak Rail Station and the South Market Street Bridge; and

Whereas, the park is close to a number of locations connected to the history of the Underground Railroad that network for courageous blacks and whites whose efforts enabled thousands of enslaved human beings to escape to the blessings of freedom; and

Whereas, Wilmington has no physical remains from the era that mark these locations, which included the road from the south over the Christina bridge at Market Street, over which Harriet Tubman led hundreds to freedom at the end of repeated dangerous trips to slave areas, and the nearby home of Thomas Garrett, who lost most of his material possessions in punishment for helping slaves escape to free states; and

Whereas, it is appropriate that people today have a continual reminder of the past evils of slavery, and the courage of individuals from varied backgrounds who risked their lives and fortunes to free others from its chains.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON that the Council recommends to the Riverfront Development Corporation that the new riverfront park at the foot of King Street be named the Tubman-Garrett Park, and that appropriate commemorations of their work and the association of the site with the Underground Railroad be included in the park's design.
